In the reference 1st read above, the Government have appointed the Commissioner and Inspector General of Registration and Stamps, A.P., Hyderabad as Registrar of Chits, the Additional Inspector General-I O/o. the Commissioner and Inspector General of Registration and Stamps, AP, Hyderabad as Additional Registrar of Chits, the Joint Inspector General-I, O/o. the Commissioner and Inspector General of Registration and Stamps, AP, Hyderabad and Deputy Inspector General of their respective zones as Joint Registrar of Chits, the Assistant Inspector General (Chits), Office of the Commissioner and Inspector General of Registration and Stamps, AP, Hyderabad and the District Registrars of Registration Districts in the State as Deputy Registrars of Chits and the Chit Registrars as Assistant Registrars of Chits within the limits of their respective jurisdiction for the purpose of discharging the duties imposed upon the Registrar by or under the said Act as the case may be.

In the reference 2nd read above, the Registrar of Chits has delegated some of his duties to the above officers so appointed

In the reference 4th read above, the Commissioner and Inspector General, Registration and Stamps and Registrar of Chits, Telangana, Hyderabad has submitted a proposal stating that a need has arisen in the wake of reorganisation and creation of new districts and consequent reorganisation of the department and requested to appoint officers of the Department as various officers under Chit Funds Act, 1982 a fresh.

Government after careful examination of the matter, hereby accept the proposal of the C&IG of R&S, T.S. Hyderabad for Appointment of Registrar of Chits, Additional Registrar of Chits, Joint Registrar of Chits, Deputy Registrar of Chits and Assistant Registrar of Chits.

Accordingly, the following notification will be published in an extraordinary gazette of the State dated: 11-10-2016.
